

# Delta School District #37 Election – October 15, 2022

The 2022 Election for the Office of School Trustees for the Delta Board of Education (School District #37), will be held on Saturday, October 15, 2022, at the same time as Elections for the Offices of Mayor and Councillor for the City of Delta.

### **ARE YOU REGISTERED TO VOTE?**

#### TSAWWASSEN FIRST NATION LANDS

As Tsawwassen First Nation is within the boundaries of School District #37 (Delta), TFN Residents and Non-Resident Property Electors are eligible to vote in the 2022 General Local Elections for the Office of School Trustee for the Delta Board of Education. Tsawwassen First Nation Lands are not within the boundaries of the City of Delta; therefore, TFN Residents and Non-Resident Property Electors are not eligible to vote for the Offices of Mayor and Councillor for the City of Delta.

### **AM I ELIGIBLE TO VOTE?**

#### You are eligible to vote for the Office of School Trustee as a Resident Elector when you:

- are 18 years of age or older when you register to vote or will be 18 years of age or older on October 15, 2022 (General Voting Day)
- are a resident of Tsawwassen First Nation Lands on the day of voting
- are a Canadian citizen
- have been a resident of British Columbia for at least 6 months immediately before the day of registration
- are not disqualified under the Local Government Act, or any other enactment, or by law from voting in a local election.

### You are eligible to vote for the Office of School Trustee as a Non-Resident Property Elector when you:

- are not entitled to register as a Resident Elector
- are 18 years of age or older when you register to vote or will be 18 years of age or older on October 15, 2022 (General Voting Day)
- are a Canadian citizen
- have been a resident of British Columbia for at least 6 months immediately before the day of registration
- are the registered owner of real property or the holder of a registered lease of the property for a term of at least 99 years, for at least 30 days before the day of registration
  - o If there is more than one person who is the registered owner of real property or the holder of a registered lease of the property for a term of at lease 99 years, only one of those individuals may, with the written consent of the majority of the owners (leaseholders), register as a Non-Resident Property Elector in relation to that property
- are not disqualified under the Local Government Act, or any other enactment, or by law from voting in a local election

#### Note:

- Landed immigrants who are not yet Canadian citizens are not eligible to vote.
- No Corporation is entitled to vote.

### **HOW DO I REGISTER TO VOTE?**

**You must be registered to vote**. The City of Delta uses the Provincial List of Electors for conducting municipal elections. If you are registered as a Provincial Voter, as a resident of Delta or Tsawwassen First Nation Lands, your name has been automatically placed on the Delta Voters List. If you have not registered in advance, you may register at a voting place on designated voting days.

# **Identification Required to Register on Voting Day**

To register on voting day you will be required to produce two (2) pieces of identification to verify identity and residency (at least one piece of identification must contain your signature). Examples of acceptable identification are:

- ✓ BC Drivers Licence/ Identification Card
- ✓ BC Services Card\*
- ✓ Canadian Citizenship Card/ Passport
- ✓ Status Card
- ✓ TFN Property Tax Notice
- ✓ Utility Bill

\*Please note that the combined BC Drivers Licence/BC CareCard is considered one (1) piece of identification.

# **Delta Voters List: Information and Privacy**

The Delta Voters List is made available for public viewing and upon request, is provided to each candidate in the election, for use as defined by the *Local Government Act*. The list contains the names of all registered voters and their residential address. If you wish to have your personal information, (your address or other information about you) omitted from or obscured on the list, you must submit a written request to the Chief Election Officer. Upon request, the Chief Election Officer must update the list provided to candidates and the list that is available for public viewing, by omitting or obscuring the requested information.

### **VOTE BY MAIL**

To vote by mail ballot, apply for a mail ballot package at: delta.ca/elections/mailballot

Mail ballots must be received by the Chief Election Officer before 8:00 pm on October 15, 2022. Return by mail or drop off at Delta City Hall. Late ballots cannot be accepted.
