Zoning Regulation Amendment

EC approved the minor amendment to delete s.4.8.(b) of the Zoning Regulation and renumber accordingly

Brunswick Point – Wedge Parcel and Right of Refusal Lands

Wedge Parcel: Executive Council discussed possible solutions to the wedge parcel of Brunswick Point lands, based on a conversation between BC and TFN staff. Executive Council directed the CAO to work towards a solution for the wedge parcel in conjunction with BC and Delta where appropriate.

Right of Refusal Lands: That Executive Council direct the CAO to investigate possible purchases of the Right of First

Refusal.

Climate Change Adaptation Project Proposal

EC passed a resolution supporting TFN to submit a proposal under the coordination of the Naut'sa mawt Tribal Council to receive grant funding toward a climate change adaptation project, similar to the attached draft resolution.

Sports Field Park Design

EC received a North Park Concept Overview (Park name still to be decided). Urban Systems will initiate a detailed design, and will continue working with EC and begin consulting with Elder's, Youth and Community Members on the details of plazas, playground design, Fitness equipment, how to incorporate Coast Salish designs etc.



TFN Utility Service Delivery Options (Sewer Operator Strategy)

Urban Systems presented different structural models for TFN to consider for delivering sanitary and water services to Tsawwassen Lands. We are hoping to have steps 1-5 complete within 3-5 months. Next steps:

- TFN staff meets with communities that are successfully using a different models like joint venture, P3, Performance based services and fees for services approach for the delivery of sanitary and water services.
- 2. Touch base with the Executive Council on the options reviewed and recommendations going forward.
- **3.** TFN proceed with Request for Expression Interest (RFEI) from qualified companies and meet with them to confirm project scope and other details.
- **4.** Determine the legislative requirements.
- 5. Evaluate the submissions from qualified firms.
- 6. Negotiate as agreement with the successful firm.

Request for fish for a Haida Gathering in Vancouver on February 2, 2014

Executive Council agreed to donate 10 fish to this cultural event which TFN Members are participating in.

2014/2015 Draft Budget

In accordance with the *Financial Administration Act* the Finance and Audit Committee submitted a recommended annual 2014/2015 annual budget to Executive Council, which received the for review and eventual approval. EC will hear from specific managers next week in respect of specific topics, and will approve the budget on Jan 29th, Feb 6th, or at a special meeting of EC, to meet required timelines.

Service Agreements with Delta – EC has directed the CAO to submit the following Service Agreements to the Corporation of Delta for their review.

- 1. Police Services;
- 2. Enhanced Police Services;
- 3. Fire Protection Services;
- 4. Drainage and Irrigation;

- 6. Animal Control;

Building Communication with EC and the Community

EC will host an informal breakfast with the Community from 9:00-11:00 on Sunday, February ^{2nd} This will continue on a quarterly basis either as a breakfast, lunch or dinner.

EC will attend the Elder's lunch at least once a month with Jan. 16th being the first joint lunch.

TFN's Investment Risk Profile

EC received a presentation from Greystone on TFN's investments and will work with staff and Greystone to re -evaluate the risk profile and define specific investment purposes for the Treaty Settlement Trust, Fisheries Trust and general fund portfolios.

Standing Committee on Language and Culture (SCLC)

Executive Council approved the Terms of Reference for the Standing Committee on Language and Culture. The SCLC representatives will be appointed at the Spring Session of the Legislature in February on recommendation from the Chief.

Participation in the Kinder Morgan Environmental Assessment

Executive Council directs staff to work with LGL Consultants to develop a submission to the National Energy Board to apply for Intervenor status and to apply for funding to support participation in the Environmental Assessment process. The proposal, particularly the increased marine traffic and spill risk, has the potential to adversely impact TFN and TFN's Treaty Rights.

Hunting Regulation and Guide

Executive Council reviewed and discussed the Hunting Regulation and hunters' guide, and directed staff to present EC's feedback on the regulation and guide to the Natural Resources Advisory Council for review and deliberation before returning to Executive Council.

Discharge of Firearms Regulation

Executive Council reviewed the Discharge of Firearms Regulation and provided feedback, and directed staff to present the regulation to the Natural Resources Advisory Council, Advisory Council and leaseholder consultation committee for review.

TFN Response to BC Environmental Assessment Office VAFD approval

Executive Council direct staff to send correspondence to the Provincial Environmental Assessment Office, copying Port Metro Vancouver, who are the federal approval authority in respect of this proposal.

School Bus Transportation Options

Last year the Delta School District announced that bus services to all children would be cut due to provincial funding cuts. Staff, parents and the Delta School District will be meeting over the next few weeks to decide on a number of considerations in respect of transportation of students in the Delta schools

- TFN's position in respect of the discussions/negotiations with the Delta District;
- Alternatives to ensuring that TFN students are able to get to and from local schools;
- The relevant catchment area for TFN students, which is currently Ladner Elementary and Delta Secondary School; and
- The process and timelines involved with resolving these issues


Bulk Water and Sanitary Trunk Master Plan

Executive Council adopt the Bulk Water and Sanitary Trunk Master Plan dated January 2014 as a policy to guide the development of TFN Lands.

Executive Council direct Administration to continue to implement water conservation practices as outlined in the Bulk Water and Sanitary Trunk Master Plan.

Budget 2014-2015

Executive Council reviewed and approved the annual budget for the next fiscal year and recommend the annual budget be submitted to the Tsawwassen Legislature before the third Monday in February in accordance with the *Financial Administration Act*.



Approving Officer Appointments

Executive Council of the Tsawwassen First Nation hereby appoints Charles Nash as approving officer and authorize him to act in that capacity under the *Land Title Act* (BC), or another enactment, whether of BC or of TFN, under which an approving officer has powers, duties or obligations.

Community Action Initiative Grant

Executive Council is in full support for staff to move forward with the Community Action Initiative Grant. The grants purpose is to assist families with dependent children, including adult children, who are affected by mental health issues, problematic substance use and/or unhealed trauma. This grant application partners with Tsleil-Waututh First Nation, Katzie First Nation, Fraser Health Autority, Surrey Women's Centre and BC Society for Male Survivors of Sexual Abuse.

Approval of contract to install internet conduit

Executive Council approves of a project to procure and install conduit to connect TFN's IT network through fiber optic cabling.

Health & Wellness Strategic Plan Update

Executive Council views the Health and Wellness Strategy as an important initiative to TFN. There are several aspects to the plan and many strategies are in the planning stages and have not yet been initiated.

Great Blue Heron Way Delegation

Executive Council approved the next steps in the implementation of the Great Blue Heron Way trail concept as follows:

- 1. Approve in principle the Great Blue Heron Way concept as a legacy trail project at the Gateway to the Salish Sea and Fraser River and the GBHW working group to introduce the GBWH and the Trans Canada Trail alternate route to other First Nations/neighbours as a means to link traditional territories, languages and cultures.
- 2. Approve the use of the GBHW logo on trail signage within TFN lands.
- 3. Give TFN's blessing to Ruth Adams to speak on behalf of TFN to introduce the GBHW to other First Nations.
- 4. Consult with the Community on the Community Housing Plan (Neighbourhood Plan) to determine where the future location of the GBHW trail should be.
- 5. Have staff and the Natural Resources department to take steps to ensure the trail network does not interfere with traditional uses such as gathering of medicinal plants and hunting.
- 6. Erect signage to identify the future location of the GBHW on TFN lands.
- 7. Provide staff support to GBHW to hold a multi stakeholder workshop to develop an action plan within and beyond TFN lands.
- 8. Provide staff support to work with the GBHW to implement the action plan.

Draft Advisory Design Panel Terms of Reference

Executive Council reviewed the draft Advisory Design Panel Terms of Reference and refer it to the next Advisory Council meeting for comments. The purpose of an Advisory Design Panel is to review applications submitted by developers when they propose to construct new buildings on TFN lands and to ensure these applications meet the intent of the regulations. The Panel will be considering such items as the design and appearance of the building site layout and landscaping.

Brunswick Point Update & Strategy

Executive Council authorized staff to negotiate on the sale of the Brunswick Point Lands with the

Ministry of Fisheries, Lands, and Natural Resources.

Delta Port Way Pedestrian Overpass over BCR Trackage

Staff are submitting a request to Port Metro Vancouver to construct a pedestrian overpass over the BCR railway north of the existing Detlaport way road overpass to improve safety of pedestrians and bicycle crossing conditions.

Port Metro Vancouver Construction of Interpretive Area

Port Metro Vancouver has committed to building an interpretive centre at the edge of the Salt March, adjacent to the Deltaport overpass as part of the log/removal habitat banking work that has been undertaken. Staff are in discussions with Port Metro Vancouver on location, maintenance and other details.

2014/2015 Minors Distribution Schedule and Update

Executive Council direct staff to send Members a communication indicating that the Member's distributions for the next Fiscal Year will occur on:

- April 3, June 19, August 14, and November 27 (each distribution day is on a Thursday); and
- Provide the CAO with authority to direct minor distributions into Trust where TFN becomes aware of concerns over the validity of custodial documents until such time as properly notarized documents can be provided to verify declared custodial arrangements. The treatment of the planned distributions for minors will be revisited in the Fall and annually thereafter.

BMO Loan Repayment Approval

Executive Council approves transferring funds from the Commercial Lands Corporation to BMO for the repayment of the outstanding infrastructure loans.

Distribution and Investment Plan

Executive Council has been working hard on a plan related to distributions and investments since the fall of 2013. Executive Council has reached an agreement on a Member's distribution and investment plan moving forward. This plan will be presented to the Legislature later this session, which will launch a community consultation on the plan. The community consultation will include a written document and meetings at TFN, Vernon, and Bellingham.

In the meantime, however, Executive Council is pleased to announce a couple of the decisions relating to immediate distributions. As follows:


In terms of distributions, Executive Council will be making an immediate distribution of \$2,000, which represents a one-time distribution to Members from the IC/PDG commercial lease.

Executive Council is also recommending that the \$500 quarterly distribution be the minimum annual distribution for Members on an on-going basis.

Executive Council approved an order to amend Schedule 1b of the Appropriation Act to allow for the one-time Member distribution.

Commercial Salmon Licence Purchase

Executive Council directs the Natural Resources Department to put in an offer to Pacific Broker for four Commercial Licenses at \$55,000.



Executive Council are in support of holding the next election in April of 2016.

Report on Supplementary Design Guidelines

Executive Council approved the Supplementary Design Guidelines and Construction Specifications.

Social Assistance Policy Amendment Approval

The Executive Council of the Tsawwassen First Nation hereby directs the Manager to vary the First Nations Social Development "Social Development Policy and Procedures Manual BC Region" by exempting payments from the February 27th, 2014 special distribution from the calculation of social assistance payments to all Persons with Persistent Multiple Barriers and Persons with Disabilities who are in receipt of social assistance from Tsawwassen First Nation. For greater certainty, this exemption does not apply to social assistance recipients who are considered employable.

Kinder Morgan presentation

Executive Council, for information purposes only, received a presentation from Kinder Morgan on the Trans Mountain Expansion Project.

Drainage Study Report

Executive Council directs Administration to finalize the Tsawwassen Drive North Drainage Study Part 1 Draft Report with Urban Systems (USL) by incorporating further feedback received from Executive Council, relevant comments from development partners, and any TFN Member feedback.

Once the report is finalized, it will be placed on the TFN website and distributed as a final version to development partners.

Zoning Amendment for Sewer Plant

Executive Council pass the order thereby directing Administration to amend the Industrial I1 Zone as follows:

Part 3 – Definitions is amended by **inserting** the following definitions in section 3.1 in alphabetical order:

Utilities – Means the utility infrastructure that may have an impact on adjacent uses by virtue of its potential emissions or effects, or their appearance, and may include: works yards

for government services, wastewater treatment facility, water treatment facility, pumphouses, water towers or tanks, utilities and services.

Establishment of Zones is amended by adding **Utilities** as permitted use to the **I1Zone Industrial.**

Change to TEDC Articles of Incorporation

Executive Council approved amendments to the Articles of the TFN Economic Development Corporation as follows:

- 1. That TFN EC representatives on the Board be re-established every 3 years coinciding with the TFN election date; and that External Directors are on 4-year terms staggered in 2 year periods.
- 2. That there be no limit to the number of terms that any Director can serve on the TEDC Board subject to re-appointment by EC.

Amendment to Consolidated Fees Regulation

Executive Council amended the Consolidated Planning and Development Application Fees Regulation.

Approval of preferred partners - Building Construction & Security Joint Ventures

That Executive Council approve of entering into joint ventures for both a security and building construction firm, subject to Executive Council's approval of respective joint venture with each partner agreements and subject to Executive Council approval of feasibility study or due diligence report for each venture.

Housing Strategy Report for Legislature

Executive Council reviewed the Housing report in preparation for presentation to the Legislature next week.

Sacred Trust Initiative

Representatives of the Sacred Trust Initiative presented to Executive Council on Tseil-Waututh's Nation's opposition to the proposed capacity increase in the Kinder Morgan Westridge terminal; the dredging of Burrard Inlet and the increased size and frequency of the crude-oil-carrying tankers proposed to carry crude oil to offshore sites.

Proposed Amendment to Government Employees Act

Executive Council orders that the proposed *Government Employees Act* (Bill 2 - 2014) be tabled for consideration by the Tsawwassen Legislature. The amendment proposed is to add a definition of spouse to the Act and provide spouses with second priority for hiring decision of the Tsawwassen Government. Under this option, members of other First Nation would receive third priority. EC also directs that TEDC give the same direction to developers when negotiating Member benefits.

Appointments to the Judicial Council


Executive Council will re-appoint 4 members of the judicial council, the Chair, vice Chair and two other members. EC will be running an appointment process to appoint a new TFN Member representative for the Judicial Council. EC directed staff to reach out to the legal and aboriginal communities to identify an aboriginal representative for the next term.

Report from the Standing Committee on Language and Culture

The Chief will be making a recommendation to the Legislature on who should be the 5 new Members appointed to the Standing Committee on Language and Culture.

Distribution and Investment Plan

Executive Council received a revised version of the Distribution and Investment Plan which will be presented to the Legislature on March 11th. It will then be sent to Members, and then discussed with the community at sessions in late March in TFN, Vernon and Bellingham.

Service Agreement Approval

Executive Council approved the renewal of the following agreements with the Corporation of Delta: Animal Control, Emergency Management, Dike Maintenance, Fire Protection, Drainage and Irrigation, Water, and Boundary and Local Roads. The Parks and Recreation Agreement will not be renewed; however, TFN Members can continue to access all Delta facilities. The terms of the current Police Services Agreement will remain in place while TFN and Delta continue discussions on renewal.

Brunswick Point Purchase

Executive Council provided direction to the CAO to continue negotiating with BC for the purchase of initial phases of the Brunswick Point Lands.

Budget Amendment Report

Executive Council approved a budget increase for additional grant funding for the AFROG Program, and a further amendment for the extension of the recent distribution to 7 additional TFN Members.

Approval for TEDC Cardlock Subdivision Plan

Executive Council authorizes TEDC to apply for subdivision approval for the Cardlock site.

2014 Compensation Rates for FSC Crab and Fish and per child allocation

After consultation with the Natural Resources Committee, Executive Council approved

- a) the 2014 FSC compensation rates at \$5 per crab, \$13 per piece for sockeye, \$2.50 per pound for White Chinook and \$4.00 per pound for Red Chinook.
- a) the proposed amendment to the FSC Crab Distribution Policy to increase the FSC allocation for children from 5 pieces to 10 pieces per child.

Executive Council authorizes Mike Baird to the LFFA delegate and Laura Cassidy to the alternate delegate to participate in LFFA with other First Nations within the Lower Fraser and work on common issues arising from the management of the fish and fish habitat.

Update on Brunswick Point

Executive Council direct the CAO to continue negotiating with the Province for a purchase of the Brunswick Point lands

Fishing Rights

Executive Council direct that the Chief work with staff to finalize a joint letter to DFO regarding concerns with fishing rights of other First Nations in the Fraser River.

Funding Application for referral participation in Trans Mountain Project

Executive Council authorizes TFN to enter into a Contribution Agreement with the National Energy, in respect of TFN's participation in the Joint Panel Review of the Kinder Morgan Trans Mountain Pipeline Expansion Environmental Assessment.

Amendments to the SCLC Terms of Reference

Executive Council amended the SCLC Terms of Reference, which implement the direction given by the Legislature by resolution on March 13th, 2014 and which correct some typographical errors. The changes open the SCLC meetings to TFN Members and invited guests and allows for the current 5 SCLC Members to receive a \$50 honorarium and other attendees will receive a \$25 honorarium (excluding support staff and Executive Council) effective April 1, 2014.

Authority to sign Commercial License Purchases

Executive Council authorizes the Manager of Natural Resources to sign agreements to purchase 3 salmon licences.

Housing Committee Scoping Memo

Executive Council approved the creation of a Housing Committee which will be responsible for con-

sidering and debating issues related to TFN Member Housing, and reporting back to Executive Council on its findings and recommendations. These will be open meetings with a \$50 per meeting honorarium for Committee Members and a \$25 per TFN Member.

Rokstad Letter of Cooperation Proposal

Rokstad is a Canadian owned and operated company that has become one of the fastest growing power line contractors in the transmission industry. Rokstad is bidding on the BC Hydro Regionally Optimized Distribution maintenance contract for transmission lines. The projects provide a range of opportunities to involve Aboriginal community members, including traffic and flagging, civil/labour, machine operation and first aid and potential variety of other jobs.

Executive Council approved the execution of the Letter of Cooperation between Rokstad Power and TFN. There are no financial or legal obligations associated with the execution of the letter, and it is a non-binding letter outlining an intent to co-operate further.

School Bus Transportation Update

Staff have proposed several busing route options, Executive Council directs staff to discuss those options with ALL parents, by having a meeting with the parents and follow up with a questionnaire and/or phone calls to ensure all parents input is received.

Staff will continue to work with the parents and the Delta School District on catchment area options.

Opportunity for engagement, National Marine Conservation Area

Chief Williams, Councillor Cassidy along with a staff person will attend a workshop to explore the working relationships between First Nations and Parks Canada Agency, in respect of managing protected areas, and will feature First Nation representatives from Gwaii Haanas, Champagne and Aishihik First Nation who will be sharing their experiences respecting the co-management arrangements that they have established with Parks Canada Agency.

Procurement Policy Review

Executive Council directs staff to review and consider whether amendments need to be made to the procurement policy, to reflect TFN's growth and growing TFN member company base.

Delta Port Pumpstation Initiative

Executive Council awards Urban Systems Ltd. the contract to design and manage the new Industrial Lands Pump Station. TFN will competitively tender the pumpstation construction work.

Disposition of a Social Housing Unit

Executive Council hereby approves the Social Housing Land Availability Regulation No. 3; and authorizes the CAO to execute documents necessary to affect a disposition of the parcel of land referred to in the Regulation

TFN Grad Dinner Date

Falcon Way Playground: \$35,000 expenditure—The 2013-2014 Capital Budget included \$25,000 for this project. A design and three quotes in accordance with the procurement policy were received during the 2013-2014 fiscal year, however works were not completed during this period. At that

time, it was recommended to add a swing set to the playground replacement and that this would come at a cost of \$10,000.

In order to move forward with playground replacement, a budget adjustment in the current 2014-2015 fiscal year is required. Note that the quotes previously received from contractors are no longer valid and require update.

South Neighbourhood Plan: \$32,000 expenditure—The 2013-2014 Capital Budget included an expense of \$100,000 for this project, offset by \$59,613.61 estimated revenues based on the proportional cost of the plan being covered by landowners undergoing development. The landowner development partners Mosaic covered half of this cost, amounting to \$29,806.81 in revenues received during the 2013-2014 fiscal year, and have agreed to cover the other amount owing upon plan adoption. During the 2013-2014 fiscal year \$71,349.93 was expensed.

In order to complete this project, it is anticipated \$32,000 will be required as a contracted services expense to cover cost of drafting the plan, additional consultation and plan finalization. Note that an additional \$29,806.80 revenue will be provided by Mosaic upon plan adoption.



Wilson family group Rights and Title Case

The Wilson family group who refer to themselves as the Hwlitsum First Nation are making a rights and title claim to a large area that includes all of TFN lands and the Brunswick Point Right of First Refusal lands. TFN will join in this litigation as a defendant, in order to ensure TFN's rights and interests are considered and protected.

Pre-Construction Grant Policy

Executive Council approved of specific clarifications to the policy concerning its application to primary residences (i.e. it does not apply to additional houses or to situations where the Member has moved for purposes of development, not some other purpose), and approved of specific clarifications to the policy concerning its application to payments from third parties (i.e. payments from third parties are accepted if they are due to be reimbursed).

Appointment of TFN Trust Society Directors

Jessica O'Rourke is appointed as a director of the Tsawwassen First Nation Trust Society for a term of three years; and that

Valerie Cross-Blackett is re-appointed as a director of the Tsawwassen First Nation Trust Society for a term of three years.

Follow-up on Legislator Resolutions

Staff will provide EC recommendations on the 5 Legislative resolutions that were passed at the fall 2014 session of the Legislature. The 5 Resolutions are listed:

- Motion to provide the Squiqel with an honorarium
- Motion to increase the number of Legislators to 13
- Motion to examine options to support training at non-accredited institutions
- Motion to create more transparency within the Tsawwassen Government
- Motion to protect and preserve land for current and future growth of Membership

Framework Agreement for Home Loan Guarantees with Envision

Executive Council approve of the TFN-Envision Financing program parameters, substantially in the form presented. Staff will report back on why renovations are only \$75,000, and whether there is flexibility in this item.

Cemetery Committee and Draft Cemetery Plan

Executive Council appointed a list of Members to form the Cemetery Committee (open meet-

ings). Executive Council direct staff to bring forward lot options for future Cemetery.

Water Metering Report

Executive Council endorses the following recommendations:

- a. Focus the initial metering program on new residential and commercial development and add metering on existing community buildings and member homes later once costs have been finalized and public consultation has occurred;
- b. Defer the supply and installation of fire service meters for the Tsawwassen Mills Mall and Tsawwassen Commons development until the meter and reading technology has been selected; and,
- c. Assign the developer with the responsibility for supply and installation of all components of the meter assembly, with the exception of supply and installation of meters that are 25mm and smaller to be completed by TFN.

That Executive Council authorizes staff to proceed with issuance of a Request for Proposals for water metering services. Executive Council clarified that further consultation/back to EC would be required before any metering of Member homes.

Longhouse Repair Update & Plan

A Longhouse Committee has been re-formed, the committee will give direction on the stairway modifications and floor renewal, as well as consider a list of larger renovations.

Climate Change Grant

That Executive Council pass a resolution supporting TFN to submit a proposal, under the coordination of the Naut'sa mawt Tribal Council, to receive grant funding toward a climate change adaptation project.

Authorization for Pump Station

Executive Council authorizes the CAO, to approve the invoices of an amount greater than \$75,000 related to the pre-design, design and construction of the Tsawwassen Deltaport Pumpstation (the "Project"), provided that the invoices are for works required to deliver the Project.
