Executive Council 2013—2016

Councillor Ken Baird, Chief Bryce Williams, Councillor Tony Jacobs, Councillor Louise Ahlm and Councillor Laura Cassidy

Amendment to Executive Council Remuneration Regulation

Executive Council amended the Chief and Executive Council Remuneration Regulation to correct a drafting error.

Carving Shed Update

Executive Council direct staff to consult with the Longhouse Committee on timing of construction and on design details at the next scheduled meeting and to return to Executive Council for final approval to proceed, to award a contract, and to approve a budget adjustment to the Capital Budget to construct a carving shed addition to the longhouse.

Cultural Society

Executive Council approve recommendations to allow the First Nation Cultural Society to be dissolved.

Update on TFN Participation in Panel Review of Transmountain Project

Executive Council approves TFN continuing to participate as an intervenor. Staff, working with outside legal counsel and technical advisors, to continue to identify, frame and communicate issues to both the proponent and government regulations.

Form and Character Development Permit Guidelines for Multi-Family Projects

Executive Council direct staff to begin consultation on the Draft *Multi-Family Residential Use Development Permit Area*.

Increasing the size of the TFN Legislature

Executive Council resolve to introduce a Motion at the next sitting of the Tsawwassen Legislature to increase the number of Legislators to be elected to 13 by amending the Government Organization Act. That Executive Council subsequently amend the Voting and Mail-In Ballot Regulation to bring effect to that change.

Small Business Grant Program

Executive Council approve the revised Small Business Grant Program Guidelines and Procedures.

Appointment of a new External Director to TEDC Board

Executive Council approved two shortlisted candidates to interview and assess their suitability as an external Director for the TEDC Board; and subject to the interviews EC appoint one of these candidates to the TEDC Board.

Sports Field Trucks on Falcon Way

Executive Council opted not to permit Sports Field Trucks on Falcon Way from Jan. 20th—Jan 22th, and accepted that there may be a week-long delay in the Sports Field construction timeline.

Vancity Home Loan Program (verbal update)

TFN has received the supporting legal documents from VanCity and have TFN's legal counsel review and should be able to finalize the documents soon enabling Members to access the program. Vancity is ok to advance funds up to the foundation. Member's will be notified once the program is in place.

Longhouse Committee Draft Policy

Executive Council approved the draft Longhouse Committee Policy subject to the following changes:

- If there isn't a syewen person identified for the Chair, Vice Chair or Elder at the AGM, that the longhouse committee will identify a TFN Member to recommend to EC for approval to fill that position; and
- A Tsawwassen Member that is an appointed Member of the Committee is entitled to a \$50 honorarium payment per meeting and that any other Tsawwassen Members who attends an Longhouse Committee meeting is entitled to a \$25 honorarium payment per meeting.

Update on Specific Claims (Donovan & Co)

Executive Council authorize continued work by Donovan & Co and the Specific Claims Research Centre in respect of Specific Claims Research Centre in respect of Specific Claims of TFN, and authorize a request for continued funding to Aboriginal Affairs and Northern Development Canada, and permit the above law firms to access TFN related records in order to continue this research.

PMV Air Quality Monitoring Plan

Executive Council direct staff to sign off on the Air Quality Monitoring Plan. This work arose from Community concerns from both Members and non-Members on specific air quality concerns.

Approval of Spring 2015 Legislative sitting

Executive Council calls the Tsawwassen Legislature into session on Wednesday, February 11, and run, as required, until approximately Tuesday, March 17, 2015.

LFFA Chinook Fishery Management Model

Executive Council agrees to support the Lower Fraser First Nation by committing to funding to a joint judicial review of DFO's management model for Chinook. Musqueam, Sumas, and Katzie First Nations have already agreed to contribute \$2,500 this fiscal year and commit to additional contributions as required in support of the judicial review of DFO's Management model for Chinook.

Crab Lease Content – policy memo

Executive Council direct staff to consult with current crab leaseholders and with the Natural Resources Advisory Committee on options presented by staff.

Reach for the Stars 2015 Sponsorship

Executive Council agreed to support the Reach Child and Family Youth Development Society by purchasing a table for the event

Feedback on New Waste Management Process (verbal)

Executive Council provided feedback received by the community to date. Staff will coordinate two information sessions, one for the community and one for staff members.

Honorarium for the Squiqel

Executive Council will introduce an amendment to the Government Organization Act to increase the Legislative stipend paid to the squiqel by 25 percent. If there is a vacancy in the office of squiqel, the legislator chosen to replace the squiqel will receive a \$100 honorarium per meeting.

Request from Corrections Canada to Access Tsawwassen Lands

Executive Council direct staff to e-mail Corrections Canada indicating that a request on behalf of a First Nations offender in the parole system to permit access Tsawwassen Lands in order to take training at the Gateway Skills Centre was denied. Staff will work with Corrections Canada on a protocol agreement for the purpose of setting out how these requests may be handled.

Treaty Day Brief

EC approved holding the Treaty Day on April 2nd, as April 3rd is Good Friday. The hours will run approximately from 12:00—3:30, a detailed agenda will go out in the Community Notice.

RFP for Community Housing Plan

Executive Council direct administration to finalize the TFN Community Housing Area Plan RFP document and post for tender.

Commercial Salmon Allocation Framework (10:00 am)

EC received a presentation on the Commercial Salmon Allocation Framework defined in the Salmon Coordinating Committee's proposal as information. Staff will return with a draft proposal document for EC's approval.

Executive Council approves providing Longhouse Committee members and participants to receive honorariums (according to the Longhouse Committee Policy) for each meeting attended since December 4, 2014.

TEDC Board of Directors Appointment

Local and Boundary Roads Maintenance Agreement

Executive Council authorizes TFN to seek a 6-month extension of the existing roads agreement with the Corporation of Delta.

Minors Trust Information Brief

Executive Council instruct staff to put the total amount of all distributions for minors directly into the Minor's Trust, with no option to take out half. An information letter has been sent to all Members, as well Tom McCarthy will attend the next Advisory Council meeting explaining this decision.

South Area Neighbourhood Plan

Executive Council adopt the South Neighbourhood Plan and direct staff to implement the next steps.

Approval of TFN and Delta Policing Agreement

Executive Council approves of The Corporation of Delta and Tsawwassen First Nation Police Services Agreement ("the Agreement"), dated for reference April 1, 2014, and authorizes the Chief and Chief Administrative Officer to execute the Agreement and to take all other steps necessary to give force to the Agreement.

TFN Specific Claims

Executive Council approved the order providing Ratcliff & Company with the authority to apply for funding and undertake post-submission research on TFN's behalf.

2015/2016 Consolidated Budget Approval

EC approved the 2015/2016 Consolidated Budget to be presented to the Legislative Assembly for approval.

3-year Budget Approval

Executive Council approves the Multi-year Budget as required in the Financial Administration Act.

Metro Vancouver's Transit & Transportation Presentation

EC received a presentation on the Metro Vancouver's Transit and Transportation Referendum. Staff will provide information to Members and leaseholders on how this referendum will affect TFN.

Breakfast or Dinner with Executive Council

Executive Council will set up a weekday dinner with the community in mid-April.

Mapping of Traditional Plant Areas in Tidal Marsh

Natural Resources will return with a proposal to fence off areas that Qexmin grows, possibly looking at both a pedestrian and ATV trail along Tsawwassen Drive, fencing off from traditional medicine.

Process of Study on EC/Staff Dual Role

Executive Council approve of proceeding with an Request for Proposal for an independent study on the appropriateness of a continued dual role of staff on Executive Council, with a reporting timeline of September/October 2015.

Update to Marsh Boardwalk and Translink Grant

- Executive Council approved the boardwalk construction design to be a 4.2m wide wood boardwalk with non-slip surface and railings, and bollards at either end.
- Executive Council directs Administration to continue working with Translink to forward the grant application.
- Executive Council directs Administration to bring forward a detailed funding approach, and bring forward for Executive Council's consideration.

Salt Water Discharge Temporary Crossing of Tsawwassen Drive

Executive Council approve a six-inch pipe to cross the road by laying the pipe on the pavement and creating steel ramps on either side for approximately 12 weeks. Signage will be posted, adjacent property owners will be advised and the community will be notified via newsletter. The pipe will be placed on Monday Feb 16th.

Community Housing Area Plan RFP Award

Executive Council awards the Community Housing Area Plan services contract and authorizes the Chief Administrative Officer to execute the contract. EC would like to see a boundary adjustment between the north neighbourhood plan and community housing plan, for approval, as a first step.

13th Annual Children's Heart Network Wine Gala Dinner

Executive Council approves the purchase of 8 tickets and a \$300-\$500 carving for the auction.

Crab Licence Allocation

For all new leases going forward Executive Council direct staff according to the following:

- 1. In respect of current and future crab lease arrangements, TFN:
 - a. TFN set a lease rate of \$5,000/year for the first three years and a rate of \$7,500 for the remaining years of a term;
 - b. encourage license holders to hire Members by establishing a penalty for those who hire a crew of strictly non-Members.
 - c. that given the subsidizes lease rate, charged to license holders, TFN will be permitted to request some commercial crab license holders to donate some crab to TFN for FSC purposes.
 - d. that the term of existing and current leases be extended 8 years.
 - e. that TFN restrict area transfers to 3 southern locations so that the opportunities are accessible by a greater number of Members.
 - f. that leases prohibit the assignment of lease opportunities, must have a minimum of one Member on the boat at all times or subject to penalty.
- 2. Separate from lease terms, staff will begin to developing a strategy to encourage Member employment on commercial fishing vessels.
- 3. Also, staff will begin a process to contact fishers to alert them to the upcoming opportunities to utilize the crab licences and collect information regarding the readiness of fishers to make use of the opportunity. Readiness means that the Member has the equipment needed to make use of the opportunity or a plan to support the acquisition of the equipment, and that they indicate that they are prepared to commit to the fishing of the licence (e.g. they are not planning to hire staff for the duration of the term, which if permitted, could result in Members who have no interest in crabbing making use of the opportunity.)

Letter Requesting Joint Meeting with BC re BC Treaty Process Support

The Chief will send a joint letter to BC, after seeking the support of other Treaty First Nations, asking

for a collaborative meeting to discuss the future of the BC Treaty Process.

Delta Hospital Foundation Golf Tournament

Executive Council approved providing a donation and sponsorship to this cause.

Workshop on Values

Executive Council direct staff to develop and deliver, with external assistance, a series of workshops for a) Executive Council, b) the Legislature, c) management staff, d) non-management staff, and then e) all groups together, focused on developing a good understanding and alignment of the organizational vision, values and culture of the Tsawwassen Government organization.

New Westminster Reserves Specific Claims

Executive Council asked staff and legal counsel to undertake further work on the New Westminster Reserve Specific Claim.

Approval for second Phase Industrial Lands

- 1. Executive Council initiate a process that provides an opportunity for Members to vote on TEDC's proposal to negotiate development agreements (that form the basis of the lease agreements between TFN and the tenant and include the associated Member Benefits package) for the remaining 180 acres of TFN industrial lands;
- 2. That the Member vote be 50% +1 of those taking part in the vote, with a minimum participation rate of 10% of all eligible TFN voters.

Executive Council direct staff to bring back a letter indicating to DFO that TFN feels strongly that every First Nation on the Lower Fraser should be considered in this process, that TFN will not participate further in the DFO 'dialogue' process, as well as acknowledging that that any decision to grant a request based on asserted Rights could impact TFN's defined Rights and that any impact to TFN's defined Rights is a breach of the Treaty.

Phase II Industrial Land Vote

Community Housing Area Plan Consultants

Pat Hibbitts Memorial Fund
