# **TFN ADMINISTRATION: CHIEF ADMINISTRATIVE OFFICER**

### **TFN Tax Panel formed**

Executive Council has appointed a Tax Panel to advise TFN on how best to manage the change for current and future Members that will come with the tax exemptions expiry scheduled for January 1, 2022. EC understands how important this milestone is to Members and has heard the membership's growing concerns.

This work is a top priority for TFN. Throughout the year the Tax Panel with work with the EC, Legislature, Advisory Council, Members, staff and other experts as required to develop readiness strategies to ensure a smooth transition that meets the community's needs.

Members can expect to interact with the Tax Panel and have opportunities to raise questions and concerns as well as ideas on how TFN can best prepare for this milestone / change.

### Dillon Johnson, Associate, Temixw Planning Ltd., North Vancouver, BC

Dillon Johnson has been providing community, economic and financial planning advice and services to First Nations governments and organizations for a decade as a consultant with Temixw Planning Ltd. in North Vancouver. Dillon is a member of the Tla'amin Nation, where hae served three consecutive terms as an elected member of Council. He proudly carries a Tla'amin name, toqwanən (toh-kwon-non), which is a former village site and a place of significance in Tla'amin territory. He is an MBA graduate from the Richard Ivey School of Business (University of Western Ontario) and has a BCom from the University of Victoria. Dillon also holds the Certified Aboriginal Financial Manager (CAFM) designation from the Aboriginal Financial Officers Association of Canada, and he serves as the Vice-Chair of the First Nations Financial Management Board and coordinator of the Alliance of BC Modern Treaty Nations.

### **Trudy Warner**

Trudy Warner worked as the Executive Director of Huu-ay-aht First Nations from 2017-2019. She brings with her many years of working as a consultant in leadership and communications, including working on many projects for her Nation. She was instrumental in the Nations' efforts to ratify the Maa-nulth Treaty. She earned her Masters in Leadership and a Graduate Certificate in Executive Coaching from Royal Roads University.

### Kim Baird C.M., O.B.C., Hon. LL.D.

Kim is the owner of Kim Baird Strategic Consulting and offers First Nation related and strategic advice to industry, government and First Nations. While Chief of the Tsawwassen First Nation for over thirteen years, her most notable achievement was when she negotiated and implemented British Columbia's first

urban treaty, replacing the Indian Act with self-governance for her community. She spent six years on the BC Hydro Board providing her with in-depth knowledge on energy issues in BC. She is on several boards including the Canada Infrastructure Bank, Vancouver Board of Trade, Canada Public Policy Forum, and Smithsonian National Museum of the American Indian. Kim is a member of both the Order of British Columbia and the Order of Canada and holds an Institute of Corporate Director's designation.

# EDUCATION AND SKILLS DEVELOPMENT DEPARTMENT

### Language and Culture

Our drum group still meets weekly on Monday evenings and our attendance is steady at 15 to 20 people of all ages. We are learning new songs all the time and love to share a prayer and meal together before we start.

We learn from community members as well, who come in and speak about their experiences and teach learners. We are also asked to attend and drum at events and ceremonies regularly.

We put together a trip to the Museum of Anthropology at UBC on Dec. 11, where the students at the teen center had the opportunity to tour the museum.

We visited with relevant belongings in the textile research room, saw some wet site basketry that the museum looks after on behalf of TFN and Musqueam, and toured the archaeology labs. The teens will be visiting the Museum of Vancouver on Feb. 4, 2020.

### Youth Programming

Our fall Youth Leadership Retreat took us on an adventure like no other. Staff and youth saddled up for a 3-day, 2-night horseback riding adventure in beautiful Pemberton, BC.

When we arrived at the ranch, we were paired with our horses who would be our traveling companions for the next three days. The first leg of our journey was a four-hour ride into camp! The next day was a six hour ride up the mountain to the old mines.





As we traveled up and down the mountain, we all had to let go of our fears and put our faith and trust in our amazing traveling partners!

We all had such an amazing time together bonding and learning about trust and companionship. We laughed so hard our faces hurt! Our Youth proudly shared songs around the campfire with everyone. It was a memorable weekend for all!



### **Cultural Events**

The Education and Skill department facilitates numerous cultural services where tradition dictates protocol should be observed and followed.

Nov. 22: Our annual Christmas Craft fair held in the TFN Rec Centre was a major success, with 20 vendors participating from 12 the previous year.

Nov. 27: We held a house post blessing outside the new Delta iPort facility, with several drummers, brushers, and honorariums provided to honoured speakers.

Dec. 12: We opened our sacred longhouse for the winter in a ceremony open only to Members.

### **Parks and Recreation**

Our Parks and Recreation department has been working with the Delta School District and TFN's alternative learning school in leading Physical Education classes for students.

We have created a lesson plan, including multiple activities and learning outcomes based on physical literacy guidelines. We have since started weekly youth basketball, youth lacrosse and adult floor hockey.

Our Intro to Fitness Club 16 program is still going strong and TFN Memberships have increased to 64 members in December, from 50 members in September. Congratulations to all the new fitness resolutions!

As well, many Members have made use of our facilities agreement with the City of Delta, allowing Members to go swimming, ice skating, and use other amenities provided by Delta.



# HEALTH AND SOCIAL SERVICES DEPARTMENT

### Art Hive

The Art Hive has been a successful program that continues to run every Tuesday evening at the Youth Centre. TFN Members can work in groups or individually on art pieces in a therapeutic context. Supplies and snacks are provided.

### **Christmas Outreach Program**

Health and Social Services staff provided a drop-in program for all community members during the Christmas Break. This was an opportunity to provide some social interaction during the holidays, or access services if need be. Fun games, crafts and meals were provided.

### **Elders Programming**

Elders programing in this quarter included a craft fair and holiday lunches for Thanksgiving and Christmas. Programing continues to be robust and socially focused. Our elders engaged in walking club, trips out for lunches and movies, and visiting other Nations.

# NATURAL RESOURCES DEPARTMENT

### Winter Dock Closure

The TFN dock at Canoe Pass closed on Oct. 19 for the winter season. The closure is still in place as much repair work needs to be completed to restore damaged sections. One vessel remained behind after staff announced the gangway had been lifted. The owner of the vessel stated it was broken down and was told to contact staff once they were able to repair it.

Fisher FOB's were turned off to restrict access to the site and mitigate safety risks. Any attempts to jump the fence at the dock, or access the platform in any way, would be considered an act of trespass by TFN.

### **Natural Resources Committee Meeting**

The Natural Resources Committee met on Oct. 22, 2019, at the Elders Centre to welcome newly elected committee members who were elected at the Members Gathering in late September:

Male Fisherperson: Steven Stark; Female Fisherperson: Ruby Baird; Youth: William Genge; Elder Gathering: Mabel Williams; Elder Fishing: Kathy Genge; Member not a Fisher: Laura Baird.

The Committee presented items that included a proposal for pinniped (seals) harvesting, revisions to the current food fish distribution policy, alternative options for the storage of food fish for programs, and the Canoe Pass Dock Closure.

Natural Resource Enforcement Officers Brad Larsen and Kyle Flindt out on boat patrol in November doing a general survey of the surroundings.

### Unlawful harvesting

There were few identified instances regarding unlawful harvesting that were encountered during Natural Resource Department land patrol efforts. NR Enforcement staff continued to engage with hunters and community members, and encourage every individual to report any unlawful hunting or gathering.







### **Fish Allocation**

There were 611 chinook that were caught during the summer FSC (Food, Social and Ceremonial) gillnet season out of an allocation of 625 (TFN fishers harvested roughly 98% of the allocation). TFN Natural Resources staff validated 94% of the chinook caught.

There were 333 chum salmon caught during the fall gillnet season out of an allocation of 400 (curtailed due to conservation concerns) in which 83% of the allocated amount was caught. TFN Natural Resources staff was able to validate 26.7% of all harvested FSC chum salmon.



# POLICY AND INTERGOVERNMENTAL AFFAIRS DEPARTMENT

### Nisga'a joins TFN in Alliance of BC Modern Treaty Nations (ABCMTN)

On Nov. 4, 2019, Nisga'a Nation joined Tsawwassen First Nation, Tla'amin Nation, Huu-ay-aht First Nations, Ka:'yu:'k't'h'/ Chek'tles7et'h' First Nations, Toquaht Nation, Uchucklesaht Tribe, and Yuulu?il?ath Government by becoming a member of the Alliance of BC Modern Treaty Nations (ABCMTN)

Each member of the Alliance signed an updated Memorandum of Cooperation which formalizes the Nisga'a Nation's membership in the Alliance and reiterates the Alliance's commitment to

collaboratively address challenges in the ongoing work of treaty implementation in British Columbia.

As well, TFN was part of the process that brought Nisga'a Nation into ABCMTN, welcoming this inspirational Nation into an alliance dedicated to raising the profile of modern Treaty Nations in B.C. and working together on common implementation challenges.



### **Roberts Bank Terminal 2 Project**

The THC is working with the BC Ministry of Transportation to make collaborative decisions around heritage and archeology for the Pattullo Bridge Replacement Project. The meeting locations alternate On Nov. 5, 2019, the Policy and Intergovernmental Affairs between the member Nations. Tia and Victoria are pictured above at department, the Legal department, and external legal counsel held a community meeting on the Roberts Bank Terminal 2 project. the November 8, 2019 meeting at Kwantlen First Nation.

Members participated in break out tables relating to certain aspects of a proposed updated Memorandum of Agreement (MOA) with the Vancouver Fraser Port Authority (the Port) and on the Impact Assessment Agency of Canada (formerly Canadian Environmental Assessment Agency) process now and moving forward.

PIGA continues to participate in the Impact Assessment Agency of Canada process, and work on the other aspects of the file is ongoing.

### WesPac Tilbury Marine Jetty Project

On Oct. 16, 2019, the Policy and Intergovernmental Affairs department held a community meeting on the WesPac Tilbury Marine Jetty project. Members in attendance conveyed their concerns with the project, and with the cumulative, ongoing environmental effects of development throughout the Fraser Delta.

Executive Council has asserted its opposition to the WesPac Tilbury Marine Jetty Project, and has directed staff to return to Executive Council with options for opposing the project.

### **Technical Heritage Committee**

Territory Management Coordinator Victoria Williams and Archeology Coordinator Tia Williams are participating in the Pattullo Bridge Replacement Project Technical Heritage Committee (THC), along with representatives from Katzie First Nation, Kwantlen First Nation, Acting PIGA Manager Tejas Madhur, Archeology Coordinator Tia Williams (above left) and Territory Management Coordinator Kwikwetlem First Nation, Musqueam Indian Band, Semiahmoo First Victoria Williams (above right), were at Kwantlen Nation Nov. 8. Nation, Squamish Nation, and Tsleil-Waututh Nation.


### **Enrolment Quarterly Report**

The Enrolment Committee released their quarterly report in the Oct. 17, 2019 issue of the Community Notice, reporting back on the previous three months (July, August and September).

The Report stated that TFN had a population of 493 members, with 292 Members living off Lands, and 201 living on TFN Lands as of the end of September. The Report also welcomed two new Members, with a breakdown of 248 females and 245 males.

Sadly, TFN said goodbye to two respected Elders who passed away after the Report was published. TFN closed the entire government on both days of their funerals out of respect.

# LANDS AND PLANNING SERVICES DEPARTMENT

### **36-Unit Multi-Family Housing Project**

The site-preparation for the 36-unit multi family housing project has begun. The tender for onsite infrastructure (civil, electrical, landscape) is now closed and the work will commence soon.

The Design-Build tender for project has been posted on the BC Bid website for the dwelling portion only and it closes on Feb. 12, 2020.

There have been many regular sightings of eagles and hawks frequently using both the raptor poles on the site. More raptor poles will be provided on eth site once construction of the buildings is underway.

### **TFN Facilities Plan**

Facilities Planning is a significant project for the TFN community, yet very complex by nature. Considerations must be made to community consultations, clustering of membersonly facilities, costing and relocating the government services offices, and all directly impacting the short-term and long-term implementation strategy.

In October, 2019, EC approved a work plan for the Facilities Planning project. On September 27, 2019, staff posted a Request for Proposal (RFP) on BC Bid for qualified professionals for phase 2 of the TFN Facilities Planning work.

After interviews conducted by Lands Staff, EC approved MVH Urban Planning & Design Inc. at the November 26, 2019 EC meeting. Under EC's direction, the consultants have started the phase 2 work, mainly involving programming and space planning and TFN community will be consulted on an on-going basis throughout the process.



### **Coastal Flood Risk Study**

Executive Council approved the commencement of the TFN Coastal Flood Adaptation Strategy update in 2019. After collecting feedback from Members through 9 family meetings and the workshops at Members Gathering in September 2019, a Draft Phase 3 Interim Report has been prepared. The report is currently under review by Executive Council and Staff before its finalized by the consultant.

Following Phase 3, the Strategy and an accompanying Implementation Plan will be developed in Phase 4 and then subsequently implemented in Phase 5. Phase 5 may be implemented on an opportunistic basis over the course of years.

### The Blue Bridge Abutment Project

Under Executive Council's guidance The Blue Bridge Project was commissioned in October 2019 to an external contractor and was completed within two weeks.

The Blue Bridge is located on the TFN foreshore area just south of the BC Hydro substation.

### **TFN Placemaking Project**

One of the guiding principles in the TFN Land Use plan is stated as "Urban Design and Built Form Reflect Community Identity". TFN Community will be distinct, building on the long connection with the water and Coast Salish Heritage.


The TFN Placemaking project was identified as "TFN Community Identification Signs and Land Beautification" and the "Wayfinding Signs", with an approved budget for programming and construction.

Executive Council has recognized this initiative as an important legacy project to create a unique identity for TFN lands through the vision of local artists.

On Nov. 12 and Dec. 17, 2019 Executive Council approved a work plan and high-level timeline for the TFN Placemaking project. Under EC's direction, an internal TFN Placemaking Working Group meets regularly and has identified short, medium and long-term elements within the project.

TFN Placemaking Working Group will continue meeting once every two weeks to ensure this project progresses in a collaborative manner, with regular updates to EC through future reports. Community consultation will follow during the finalization of a Placemaking Strategy.





### **Brunswick Point lands acquired**

Executive Council is pleased to announce that TFN has completed the purchase of 79 hectares (196 acres) of farmland in Brunswick Point as of November 1, 2019.

The land was acquired as part of the Group 1 and Group 2 Rights of Refusal Lands designated in the Final Treaty Agreement. There are 198 hectares (491acres) of Rights of Refusal lands remaining.

With the purchase completed, the lands will remain as properties in the City of Delta, under TFN's ownership, until TFN adds them to the existing Tsawwassen Lands.

A strategy is being developed to ensure that this land purchase is followed by a robust implementation plan that meets the acquisition goals of protecting the cultural importance of the lands and ensuring TFN's long term social and economic sustainability.

A cultural celebration is being planned for the Spring. Look for details in the Community Notice newsletter and other forms of government communications.



### **Elders Centre**

Executive Council has prioritized the Elders Centre project. Based on member consultation findings, EC at the September 03, 2019 meeting, approved the location of the proposed new Elders Centre in the Blue Heron Way precinct.

The programming and space planning for the Elders centre is currently underway and once the needs are established, a suitable architect will be hired for the conceptual and detailed design phases, which will include members consultations at every step of the way.

Under EC's direction an internal TFN Elders Centre Working Group meets regularly and will continue meeting once in two weeks to ensure this project progresses in a collaborative manner, with regular updates to EC through future reports.

### **Community Housing Area**

TFN's Strategic Plan 2018-2023 prioritizes a clear implementation Plan for the TFN Community Housing Area (CHA) plan which is due for an update.

With EC's guidance, Lands Staff completed community consultation work to gather preliminary feedback from Members on land tenure, leases, and property tax assessments for lots within the CHA. Members were consulted through 9 family meetings and workshops at Members Gathering.

EC and Lands Staff are now working towards finalizing the CHA boundary, separating the leasehold area from the CHA. Staff are updating the CHA Plan by incorporating the feedback from the TFN community.

### Youth Centre

Work on the Youth Centre site is in full swing. Executive Council has asked Staff to follow the timelines as tightly as possible. The pre-load phase is now complete and the pre-load has been removed from the site. The building contract has been tendered and awarded to Converge Construction Ltd. The Youth Centre is geared for completion by early 2021 and when completed it will be a two-storey building with a capacity to accommodate up to 400 people at once.

### **ISC Renovation Grant**

TFN members living in homes older than 10 years qualify for a \$40,000 renovation grant through Indigenous Services Canada. With Executive Council's support TFN Members have received \$280,000 in grants for renovation work in Dec 2019. The Housing Planner is currently helping 25 - 30 Members get renovation grants for their homes through ISC. A community notice with information about the grant will be circulated within the community every month.

# **TSAWWASSEN ECONOMIC DEVELOPMENT CORPORATION**

### **TEDC Advisory Board of Directors**

In 2017 there was an external review and evaluation done on operations and activities of TEDC which resulted in the recommendation that the TFN government assume control over the management and operations of TEDC.

As such the CEO was replaced by the TFN CAO and the Board of Directors were replaced with EC members for the interim to oversee the day-to-day operations.

A working group was formed, led by the CAO, to oversee the recruitment process to identify potential director candidates.

Amendments were made to the Economic Development Act and Articles to reflect the requirement for having at least one director having significant financial experience and at least one director having significant expertise in land economics or real estate development, and one have significant business experience as well as one be a TFN Member, forming the TEDC Advisory Board of Directors.

### **Ron Emerson**

He joined Royal LePage Commercial, where he earned the title of top producer in Vancouver, and later in all of Canada.
