Citation

1 This regulation may be cited as the *Ticket Regulation*, 2013.

Interpretation

- 2 (1) Unless specifically defined herein, words and phrases shall be construed in accordance with the meanings assigned to them in the Tsawwassen First Nation Final Agreement or the *Community Governance Act*, as the context and circumstances require.
 - (2) In this regulation:

"contravention" means all contraventions, including all contraventions designated as offences, of a Tsawwassen Act or regulation;

"compliance notice" or "CN" means a compliance notice, as described in Part 2 of the *Laws Enforcement Act*;

"contravention ticket" or "CT" means a ticket for a contravention that has not been designated an offence, as described in Part 2 of the *Laws Enforcement Act*;

"Early Payment Discount" means the amount set out in the Early Payment Discount columns of Schedule A or the amount described in section 4 (2) of this regulation;

"enforcement officer" includes:

- (a) for the purpose of Schedule A of this regulation, an enforcement officer appointed under section 3 of the *Laws Enforcement Act* which, for greater certainty, may include a member of a police force authorized under the *Police Act* (British Columbia);
- (b) for the purpose of Schedule B of this regulation, a resource management officer appointed under section 28 of the *Fisheries, Wildlife, Migratory Birds, and Renewable Resources Act*; and
- (c) for the purpose of Schedule B of this regulation, a fishery officer as defined under the *Fisheries Act* (Canada);

"offence ticket" or "OT" means a ticket for a contravention that has been designated an offence, as described in Part 2 of the *Laws Enforcement Act*;

"Penalty" means the fine set out for each contravention in Schedules A - C;

"screening officer" means a person appointed by Executive Council as a screening officer pursuant to section 18 (1) of the *Laws Enforcement Act*;

"Surcharge" means the amount set out in the Surcharge columns of Schedule A or the amount described in section 4 (2) of this regulation; and

"Ticket" means a notice of a contravention of a Tsawwassen First Nation Act or regulation with related information issued in Form 1 or Form 2 and, for greater certainty, includes a compliance notice, a contravention ticket, and an offence ticket.

Enforcement

- 3 (1) The Acts or regulations designated in Schedule A and the sections designated in the Section columns of Schedule A may be enforced by an enforcement officer by way of a Ticket under this regulation.
 - (2) The sections of the *Fisheries, Wildlife, Migratory Birds, and Renewable Resources Act* and the *Fisheries Regulation* designated in the Section column of Schedule B may be enforced by an enforcement officer by way of a Ticket under this regulation.
 - (3) The provisions of the *Water Shortage Response Plan Regulation* designated in Schedule C may be enforced by an enforcement officer by way of a Ticket under this regulation.
 - (4) A Ticket is presumed to have been received by the person named on the Ticket:

- (a) if served on the person, on the date the Ticket was served; or
- (b) if the person is a corporation or a business, on the date that the Ticket is personally delivered to the business premises.
- (5) The use on a Ticket of any word or expression in Schedules A C to designate a contravention, or a general description of a contravention, is deemed sufficient for all purposes to describe the contravention designated by that word, expression or general description.
- (6) The general descriptions of contraventions used in Schedules A C are for convenience only, and in no way define, limit, alter or enlarge the scope or meaning of the provision(s) in the Act or regulation to which they refer.
- (7) For greater certainty, a suspension issued pursuant to a contravention identified in Schedule B may be appealed under section 39 of the *Fisheries, Wildlife, Migratory Birds, and Renewable Resources Act.*

Penalties for contravention

- 4 (1) The amount due for a contravention referred to in subsections 3(1) 3(3) is:
 - (a) subject to paragraphs (b) and (c), the Penalty in the amount established for that contravention;
 - (b) if received by the Tsawwassen First Nation on or before the 14th day after the date the Ticket was received or presumed received, the amount of the Penalty minus the Early Payment Discount established for that contravention; or
 - (c) if received by the Tsawwassen First Nation on or after the 29th day on which the Ticket was received or presumed to have been received, in addition to the Penalty, the Surcharge established for that contravention.
 - (2) All Penalties collected pursuant to a Ticket issued under section 3 (2) and 3 (3) are eligible for a 50% Early Payment Discount if paid within the timeframe established in section 4 (1) (b) and are liable for a 25% Surcharge if not paid within the timeframe established under section 4 (1) (c).
 - (3) Where an Enforcement Action in Schedule B permits automatic suspension and a \$1,000 Penalty for a severe contravention, an enforcement officer may make a determination in his or her discretion regarding whether the contravention is of the degree of severity necessary to warrant such Enforcement Action.

Time for payment or dispute

- 5 (1) A person named on a Ticket must, within 14 days after receiving it or being presumed to have received it:
 - (a) pay the amount set out in subsection 4 (1) (b) to Tsawwassen First Nation; or
 - (b) dispute the allegation contained in the Ticket in accordance with the applicable dispute process outlined in the *Laws Enforcement Act*.
 - (2) If the payment required under subsection 5 (1) or notice of dispute is not received by Tsawwassen First Nation on or before the 14th day after the date the Ticket was received or presumed received, the person named must immediately pay the full Penalty to Tsawwassen First Nation.
 - (3) Subject to a decision by a screening officer, the Judicial Council, or the Provincial Court after hearing a dispute, if the payment set out in subsection 5 (2) is not paid within 29 days of receiving the Ticket, the person named must pay, in addition to that amount, the Surcharge set out in subsection 4 (1) (c).
 - (4) Payment may be delivered in person during regular office hours, or by mail to the office of Tsawwassen First Nation.
 - (5) Any payment imposed under subsection 5 (2) or 5 (3) is a debt immediately due and payable by the person to Tsawwassen First Nation.

Fee if disputed compliance notice is confirmed

If, pursuant to Part 2, Division 3of the *Laws Enforcement Act*, a compliance notice is confirmed by a screening officer, or if the person in respect of whom a compliance notice is issued enters into a compliance agreement, the person in respect of whom the agreement is entered into must pay an administration fee of \$25 in addition to the amount of the penalty, or the amount of the penalty and surcharge.

General

- 7 (1) Schedules A C, Form 1, and Form 2 are attached to and form part of this regulation.
 - (2) This regulation comes into force on the date of its enactment by Executive Council.
 - (3) Upon enactment of this regulation, the Tsawwassen First Nation Ticket Regulation, 2009, is repealed.
 - (4) All Penalties collected pursuant to a Ticket issued under section 3 (2) are to be tracked separately by the Director of Finance and may only be used to fund activities that support
 - (a) the restoration of fish habitat;
 - (b) the training and development of youth fishers;
 - (c) the participation in selective fisheries; or
 - (d) other activities related to the support and enhancement of Tsawwassen fisheries that may be recommended by the Manager of Natural Resources in consultation with the Natural Resources Advisory Committee.
