Citation

1 This regulation may be cited as the *Annual Rates Regulation (2009)*.

Definitions

2 In this regulation:

"Act" means the Property Taxation Act (Tsawwassen).

Annual Rates

- 3 The tax rates shown in Schedule A are imposed and levied on the assessed value of all land and improvements taxable for general purposes related to the governance and servicing of Tsawwassen Lands, the regional library and the South Delta Recreation Centre.
- 4 The tax rates shown in Schedule B are imposed and levied on the assessed value of all land and improvements taxable for:
 - (a) the education equivalency, pursuant to section 22 (2) (a) of the Act, and
 - (b) the Greater Vancouver Regional District, South Coast British Columbia Transportation Authority and BC Assessment Authority pursuant to section 22 (2) (b) of the Act.
- 5 The tax rates shown in Schedule C are imposed and levied on the assessed value of all land only taxable for drainage.

Tax Payments

6 All taxes payable under this regulation must be paid on or before July 2, 2009, as stated in section 23 (1) of the Act.

7 Schedules A, B and C are attached and designated as part of this regulation.
