#### **Authority**

1 This regulation is made pursuant to section 27 of the Conflict of Interest Act.

#### **Definitions**

- 2 (1) In this regulation,
  - "Act" means the Conflict of Interest Act;
  - (2) Unless specifically provided otherwise in these regulations, the terms used have the same meaning as defined in the Act.
  - (3) For the purposes of the Act and schedules A and B of this regulation,

"interest" means a monetary or other economic interest and includes an interest to which a monetary value may be attributed, but does not include an interest that is so remote or insignificant that it cannot reasonably be regarded as likely to influence the public official in any way; and,

"members of their families" or "family member" means a spouse/partner, parent, or dependent child, as well as any other individuals who share the public official's home or are otherwise dependent on the public official for support.

#### **Disclosure statement**

3 (1) Pursuant to section 7 (1) [Disclosure statement] of the Act, the Chief and elected members must each file with the chief administrative officer the affidavit prescribed in Form A [Disclosure affidavit for Chief and elected members] or Form B [No Disclosure affidavit for Chief and elected members] of Schedule A.

(2) Pursuant to section 14 [Affidavits of directors] of the Act, all directors must each file with the chief administrative officer the affidavit prescribed in Form A [Disclosure affidavit for Directors] or Form B [No Disclosure affidavit for Directors] of Schedule B.
